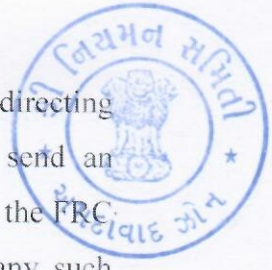

1. Proposal submitted by Jamnabai Narsee School, Block No. 40/A, Shram Marg, Zone-IV, Gift City, Gandhinagar for Nursery to Sr. Kg., Std. 1 to 5, Std. 6 to 8 and Std. 9 and 10 (ICSE English Medium) for 2019-20 along with relevant documents.
2. Provisional order passed by Fee Regulatory Committee (FRC), A'bad Zone, Gandhinagar, on 21.06.2019 for academic year 2019-20.
3. Notice issued by the FRC to the school on 17.10.2019.
4. Reply of the school received by the FRC on 21.10.2019.

**FINAL ORDER**  
**DATE: 23.10.2019**

1. Jamnabai Narsee School, Block No. 40/A, Shram Marg, Zone-IV, Gift City, Gandhinagar, has filed proposal for Nursery to Sr. Kg., Std. 1 to 5, Std. 6 to 8 and Std. 9 and 10 (ICSE English Medium) for 2019-20 along with relevant documents.
2. The FRC has considered the said proposal in light of the documents produced by the school and also in light of the order passed by the FRC for the academic year 2018-19. While passing the provisional order, on 21.06.2019 determining the provisional fees for the academic year 2019-20, the FRC has laid down certain terms and conditions. One of such conditions i.e. condition no.7 is that if the school is aggrieved by the final provision determined by the FRC, the school has a right to file objections before the FRC within 7 days from the date of receipt of the provisional order. More than 4 Months have passed and yet the school has neither raised any objection nor sent any communication informing that FRC that provisional fees determined by the FRC are acceptable to the school.



3. The FRC has therefore, issued a notice to the school on 17.10.2019 directing the school either to file its objections against the final order or send an intimation to the FRC to the effect that the provisional order passed by the FRC is acceptable to the school. The FRC has made it very clear that any such objection or intimation must be sent to the FRC within one week from the date of receipt of the said letter, failing which, the FRC will pass final order in the matter.
4. On receipt of the said notice, the school has filed its reply on 21.10.2019 stating therein that provisional order passed by the FRC is accepted by the school and hence, the school has not raised any objection.
5. Considering the reply filed by the school and further taking into consideration the fact that the school has not raised any objection against the provisional fees determined by the FRC, the said provisional fees have now become final fees for the academic year 2019-20. The final fees determined by the FRC for the academic year 2019-20 are as under.

**Terms and conditions:**

1. It is directed that the School is not permitted to collect fees for any quarter of 2019-20, more than the provisional fees determined for the year 2019-20.
2. It is also made clear that school is not permitted to collect more fees for remaining quarters of 2019-20 than the final fees determined by the Committee and if any excess fees are collected by the School either for 2017-18 and 2018-19, the same shall have to be refunded to the students or should be adjusted against the fees for the academic year 2019-20.


3. It is further made clear that the school is not permitted to collect fees under any other head including under the head of Admission Fees except one month fees by way of admission fees only in case of new admission and thereby causing no extra burden on the students. However, all such fees are to be calculated under one head only.
4. Any other fees collected under the head Transportation, uniform charges and meal or food charges or for other activities should be optional and the same should not be made compulsory. The details of such fees should also be furnished to the Committee.
5. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
6. If the school has any grievance against this final order, the school can file revision application before the Fee Revision committee, Gandhinagar within three weeks from the date of receipt of this final order, along with the challan of RS.10,000/- being filing fees.
7. The school is directed to place the order determining the final fees on its notice board as well as on the website of the school.
