
You are well aware that Fee Regulatory Committee, Ahmedabad Zone, Gandhinagar, has passed the provisional order on 11.03.2020, for the Academic Year 2020-21, determining the fees for Secondary and Higher Secondary Sections (CISCE - English Medium). The said order was passed prior to Lockdown due to pandemic of Covid-19. Considering the effect of Covid-19, on the financial position of parents and representation received by the State Government from all concerned as well as pursuant to some litigation before the Hon'ble Gujarat High Court, the State Government has issued the Resolution on 07.10.2020 stating therein that all self-financed schools in the State of Gujarat shall not make any increase in the fees for

the Academic Year 2020-21. It was further clarified that all self-financed schools will charge only Tuition Fees and will not charge any fees for optional activities/ facilities for the Academic Year 2020-21. It is also clarified that all self-financed schools shall give reduction of 25% in the Tuition Fees determined by the Fee Regulatory Committee for the Academic Year 2019-20. Since, the Fee Regulatory Committee determines the total fees as per the Provisions of Section 3 (10) of the Gujarat Self-Financed Schools (Regulation of Fees) Act, 2017, fees other than the fees charged for optional activities/ facilities, are considered under one head only and hence the relief is given to all students in the fees for the Year 2020-21 to the extent of 25% of the fees determined by the FRC for the Academic Year 2019-20.

In view of the above facts, the final order is required to be passed by the Fee Regulatory Committee, Ahmedabad Zone, on the basis of the Government Resolution dated 07.10.2020 and not on the basis of provisional order passed by the Fee Regulatory Committee. Hence, this notice is issued to you informing you about the final order to be passed by the Fee Regulatory Committee, Ahmedabad Zone, after giving reduction of 25% of the total fees determined by Fee Regulatory Committee, Ahmedabad Zone, for the Academic Year 2019-20 in respect of each standard. You are therefore requested to give your consent, within 2 Weeks from the date of receipt of this notice which shall be duly considered by the FRC while passing the final order for Academic Year 2020-21.
