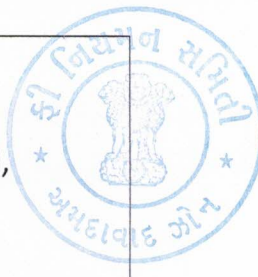

1. Jamnabai Narsee School, Block No. 40 A, Zone – 4, Gift City, Gandhinagar – 382 355, has submitted its proposal for the Year: 2021-22 along with relevant documents. After considering the said proposal and the documents attached therewith, the committee has passed the provisional order on 23.02.2022 for the academic year: 2021-22 for Pre Primary, Primary Section, Secondary Section, Higher Secondary (Gen.) and (Sci.) (ICSE English Medium). For Pre Primary Rs. 71,500/- against RS. 74,500/-, For Primary Rs. 71,500/- against RS.

74,500/-, For Upper Primary Rs. 79,000/- against RS. 82,500/-, For Secondary Rs. 86,000/- against RS. 90,000/-, For HSC – 11 (Gen.) Rs. 87,000/- against RS. 90,000/-, For HSC – 11 (Sci.) Rs. 88,000/- against RS. 90,000/- for the academic year: 2021-22.



2. While passing the provisional order certain terms and condition mention by the FRC one of such condition that is condition No.7 was that if the school aggrieved by the provisional fees determined by the FRC, the school has a right to file objections before the FRC within 7 days from the date of receipt of the provisional order.
3. Since the provisional fees determined by the FRC are acceptable to the school and the letter of acceptance is also on the record of FRC, there is no need to pass any detailed order. Accordingly determined final fees for Pre Primary, Primary Section, Secondary Section, Higher Secondary (Gen.) and (Sci.) (ICSE English Medium) as per the provisional order of FRC for the A.Y:2021-22.
4. As per the notification of the Education Department, Govt. of Gujarat published on dated 17th July - 2018 part IV-B, as per the direction of Hon. Supreme Court of india in SLP (c) 314 of 2018. regarding to specify the optional activities - facilities which may be offered or provided by the school to the student's which is voluntarily. (Notification attached herewith for your perusal.
5. As per the Section 10(1)(4) of the Gujarat Self Finance School Fee Regulatory Act. – 2017. Which ever fees determined by the FRC which is bound to the Self finance school for the period of 3 years. So as per the above Section FRC already determined the Fee Structure of your school A.Y: 2021-22, 2022-23 and 2023-24.
6. Hence the committee has determined the final fees for the year: 2021-22.

- You are further directed that any excess fees charge from the student's over and above the mention ceiling shall have to be refunded to the student's.

Terms and conditions:

- The school is not permitted to collect fees more than the final fees determined for the academic year : 2021-22.
- The school is permitted to collect the fees for the academic year 2022-23 and 2023-24 by adding 5% increase in the final fees determined by the committee for the academic year 2021-22.
- It is further made clear that the School is not permitted to collect fees under any head other than the head of tuition fees, term fees as permitted and admission fees of 1 month only in case of new admission and thereby causing any extra burden on the students. However, total of all these fees should not exceed the final fees determined by the committee.
- It is also made clear that the School should either return the excess fees collected by the School for the year 2021-22 or give adjustment thereof, in the remaining installments of fees of 2021-22.
- Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- If the School Management has any grievance against the final fees determined by the Committee, it shall have a right to file revision application before the Fee Revision Committee along with challan of Rs.10,000/- by way of filing fees.

7 The School is directed to place the final order determining the final fees on its notice board as well as its website.
